### COMMUNITY SUPERVISION

Aimed at reducing recidivism rates and facilitating reintegration, community supervision is an alternative to incarceration that allows individuals to complete their sentence outside of a prison or correctional facility, subject to certain conditions and supervision.

## DCS SUPERVISES MORE THAN 180,000 FELONY INDIVIDUALS

### *PROGRESSIVE + PERSON-CENTERED*

Our person-centered approach to supervision recognizes and prioritizes the individual needs, strengths, and circumstances of those under supervision.

We strive to empower individuals, facilitate personal growth, and support their successful transition into law-abiding and productive community members.

The person's overall well-being is taken into account, acknowledging that factors such as housing, employment, family support, and community connections play a significant role in their successful reintegration. Efforts are made to address these needs and provide appropriate referrals and support networks.

### DAY REPORTING CENTERS

We offer structured programming and support targeting high risk individuals under supervision to promote rehabilitation and help address the underlying causes of their behavior. Services include counseling, substance abuse treatment, employment assistance, and close monitoring.

### REENTRY SERVICES

We ensure each person under supervision is provided with the resources, tools, and opportunities to develop the skills necessary for successful reintegration, including access to education, job training, counseling, treatment, mental health support, and other services.

### ADULT MISDEMEANOR PROBATION OVERSIGHT

We provide oversight to misdemeanor probation entities on the infrastructure needed to ensure the integrity of the misdemeanor probation system.
